Mayor Nicol then called for committee reports and recognized Councilman Gianforte who had no report.

Councilman Nolan reminded the public that the Library would begin summer hours on June 22nd 9:00am to 1:00pm on Friday and closed on Saturday. Turning to Recreation, Councilman Nolan cited the upcoming Christmas in July and the beginning of the Summer Recreation Program that this year boasted 225 participants. He also congratulated Ms. Lembo & Kinneally on their achievement.

Councilman Garruzzo advised that the annual Night Out Against Crime would be Tuesday, August 7th. The night was an excellent opportunity for the public to interface with the Police. Food, fun and games would be featured, but perhaps most importantly, residents with children would have the opportunity to take advantage of a variety of technological inventions known as "Chips". Innovations range from finger-printing to digital photos, dental imprints and even DNA samples. All of which contribute to a child's safety in a challenging world.

Councilman Shaak advised that two storm drains on Green Avenue had been repaired and the pot hole repair program was on-going.

Councilman Gorham & Visceglia having no report the meeting was open to the public.

Lynn Schambach, 525 Harris Avenue, addressed the Council to advise them of her concerns over Single-Use Plastic Pollution. Ms. Schambach's letter is incorporated into these minutes. (see insertion).

Janet Hendricks, Leslie Avenue, advised that Councilman Garruzzo had promised a response to her letter voicing concerns over parking on the east side of Green Avenue. Councilman Garruzzo responded that the Parking Ordinance just introduced and scheduled for a hearing on July 9th, was the answer as it addressed her concerns.

There being no further public comment, the resolution, Resolution 18-71-E, that had been removed from the consent agenda for separate discussion was now considered. Due to a conflict, Councilman Garruzzo left the dais and the Council Chamber at this time.

Attorney John Jackson representing Hoffman's Restaurant T/A Waypoint 622, took exception to the proposal to ban exterior amplified music at the Waypoint location. He noted that his client had never violated the decibel level of the noise ordinance and while one summons had been issued it occurred while the new sound system was being tested and the system was now in place and controlled the sound level.

Mr. Jackson pointed out that the adjacent River House had exterior music and while there were Page 53

limitations on the hours and nature of performance, there was no outright ban. He asked for the same latitude that was extended to his competitor.

Thomas Sturman, Ocean Avenue, asked that the condition remain insofar as the Waypoint had 1000-watt speakers and, as evidenced during the Planning Board hearings, the sound system did not work.

Angie Cardin, 304 Union Lane, advised Council that for two years the neighbors had attended the Planning/Zoning Board hearings on this matter. The Board had finally passed a resolution on April 11th, 2018. That resolution contained a prohibition on exterior amplified music. On June 20th, 2018, the Superior Court denied Waypoint's application for a stay of those conditions. Ms. Cardin hoped that the Council would keep in place the ban on exterior amplified music.

On motion by Councilman Gianforte seconded by Shaak, the matter was opened for Council discussion.

Councilman Gianforte offered that he had heard nothing in the discussion that would change his opinion.

There being no further comment the matter was put to a vote. Councilmen Gianforte, Gorham, Nolan, Shaak & Visceglia voted aye on Resolution 18-71-E without modification. No nays. Passed.

The meeting was adjourned at 8:09 pm on a motion by Councilman Gianforte seconded by Councilman Gorham.

Resolution of the Borough of Brielle

A Resolution Urging the Legislature to Amend S-716, S-477 and S-1766

Whereas: While it is commendable that legislation is being considered to provide additional compensation to Firefighters with cancer, S-716 as currently written will prove to be very expensive to municipalities, and

Whereas: While it is also commendable that the statute of limitations is being extended for claims involving sexual abuse, S-477 as currently written would eliminate the statute of limitations entirely leaving officials and volunteers with the near impossible task of defending a claim that is decades old.

Whereas: Under current law family members can already collect substantial compensation for actual losses such as medical bills, lost income as well as loss of companionship.

Whereas: The combined impact of these bills would devastate local government insurance budgets at a time when the local taxpayers are being squeezed because of changes in the Federal Tax code.

Now therefore be it resolved by the Borough of Brielle that:

S-716 be amended to provide that the cancer presumption be limited to types of cancer that scientific evident establishes that Firefighters develop at a higher rate than the general public, and S-716 be amended to end the presumption at age 65 when the firefighter becomes eligible for Medicare. Alternatively, S-716 should be amended to remove volunteers and establish a special program for them along the lines recently adopted by New York, Connecticut, Michigan, Colorado and Georgia, and S-716 also be amended so that the standard to rebut the presumption remains at the current "preponderance of the evidence", and

S-477 be amended to increase statute of limitation on claims involving sexual molestation against public entities to 7 years, subject to no limitation against the molester, and S-1766 be amended to remove public entities subject to Title 59, and

A copy of this resolution be forwarded to the Governor, the legislative delegation in the district, the Governor, the Senate President and the Speaker of the Assembly.

Regarding: Single-Use Plastic Pollution — Request for Consideration of Borough Ordinance to Ban Plastic Bags, Drink Stirrers, Straws & Styrofoam To-Go Containers

Dear Mayor and Council:

Brielle is beautiful town and community. We are so lucky and blessed to live here. The Manasquan River and Atlantic Ocean are natural resources that enhance our lives all year round. We enjoy swimming, surfing, fishing, boating, water sports and access to fresh seafood. The beaches and shoreline are peaceful places for contemplation, relaxation and rejuvenation.

Each and every day, each and every one of us can find single-use plastic water, beverage and even single-shot alcohol bottles along street curbs and in the grass. Plastic bags litter the streets and can be seen hanging in bushes. Plastic straws and drink stirrers add to the plastic pollution that has been accumulating and is now found along every shoreline, beach and water way and throughout the oceans all over the planet. Theoretically, plastic is disposable, yet it is produced with indestructible materials and toxic chemicals. Styrofoam never degrades. It is time that we all truly understand that when we throw something away, there is no away. Here are some disturbing statistics:

The Environmental Protection Agency (EPA) stated in 2016 that as many as 1 trillion plastic bags are used worldwide each year and an estimated less than 5% of that plastic is recycled;

According to the EPA, in the United States alone, over 380 billion plastic bags and wraps are used each year, approximately 40% of the bags used are single-use plastic bags, and the 380 billion plastic bags require an estimated 12 million barrels of oil to create;

It has been reported that approximately 19 billion pounds of plastic garbage end up in the Earth's oceans each year, which is approximately an area 34 times the size of Manhattan covered in ankle-deep plastic waste.

The EPA has stated that plastic straws are consistently one of the most littered plastic items that end up in waterways and are harmful to fish and wildlife.

According to the documentary "A Plastic Ocean," the most recent science is proving how plastics, once they enter the oceans, break into small particles referred to as micro-plastics and enter the food chain at the microscopic level where they attract toxins like a magnet. The toxins are stored in the seafood's fatty tissues and are eventually consumed by us. This may someday affect local seaside economies.

The EPA 2014 Data Tables regarding Containers and Packaging demonstrate that in 2014, 80 million tons of Styrofoam containers were generated, and less than 5,000 tons were recycled. Styrofoam is the trademarked name for closed-cell extiuded polystyrene foam produced for thermal insulation. A May 30, 2018 article in "Science Daily" states that an impartial working-group under the auspices of the World Health Organization and appointed by the International Agency for Research on Cancer has upgraded the warning regarding

styrene, the petroleum based toxic chemical used to produce polystyrene, from "possibly carcinogenic" to "probably carcinogenic."

As Chairperson of the Environmental Stewardship Ministry at St. Mary's-by-the-Sea in Point Pleasant Beach, I am working collaboratively with Peter Ritchings, my employer and the Chair of the Point Pleasant Beach Environmental Commission, to present a public screening of "A Plastic Ocean." This will held on Wednesday, July 18th at 7 PM at the Point Pleasant Beach Municipal Building meeting room. Point Pleasant Beach, Brielle and the Borough of Manasquan share the river, the inlet and the ocean, and we believe it is imperative for our local Mayors, Borough Councils and Environmental Commissions to learn about the extent of plastic pollution that is choking the planet. The Mayors, Borough Councils and Environmental Commissions for Brielle and Manasquan and the Northern Ocean County seaside communities will be receiving an invitation to the screening very soon.

I have attached for your review a copy of the Point Pleasant Beach Ordinance 2018-08 which regulates and limits the use of plastic bags by businesses in the that borough. The ordinance documents some of the grim statistics stated above.

I respectfully request Mayor and Council to attend the screening of "A Plastic Ocean," review the Point Pleasant Beach Plastic Bag Ban and consider writing an ordinance for Brielle that bans the use of plastic bags, and the use of plastic straws, drink stirrers and Styrofoam to-go containers by commercial businesses in the Borough of Bridle. As a town and individually, we need to come together and be the solution to single-use plastic pollution.
