Councilman Garruzzo, seconded by Councilman Nolan introduced Resolution 18-98 to authorize publication in the Coast Star for a hearing to be held on August 13th, 2018 at 7:30pm at Borough Hall. Vote: Councilmen Garruzzo, Gianforte, Gorham, Nolan, Shaak & Visceglia; all aye. No nays. Passed.

Mayor Nicol then called for committee reports and recognized Councilman Gianforte who had no report.

Councilman Nolan advised that Christmas in July would take place in Brielle Park on Tuesday, July 24th, a good time was in the making. Recreation's Flag Football Program registration was starting, and the Summer Rec Program was going strong.

Turning to the Library, he advised that a Yoga Workshop would be held on August 1st from 7:00pm to 9:00pm.

Councilman Garruzzo had no report, but he cited his visit to the First Aid Building to see the new state-of-the-

art ambulance. He felt it would be a great asset to the community.

Councilman Shaak advised the public that Brielle was under mandate to cease accepting recyclables in plastic bags. Recyclables should be placed at the curb in reusable plastic buckets or their equivalent. No plastic bags would be taken. Residents who wished to bring their recyclables to the Recycling Center could bring them in plastic bags, but the bags should be emptied into the recycling bins and the plastic bags disposed of as trash.

Due to the presence of food residue, pizza boxes can no longer be recycled, and they are also considered to be trash. Information on the new requirements were posted on the Web and Facebook. Councilman Shaak is always available to answer any questions or concerns.

Councilman Visceglia having no report, the meeting was open to the public.

Stephanie Smith, 709 Union Lane, asked if the Borough had reviewed the no parking provisions for Osprey Point Drive as discussed at the last meeting.

Councilman Garruzzo explained that Chief Palmer had reviewed the matter and did not deem it advisable to amend the ordinance. Councilman Garruzzo provided an example of the other side of the coin and quoted from a letter received from an Osprey Point Drive resident who cited an increase in traffic in recent years. People arrive as early as 5:00am, they slam car doors, drop their boats in the street and shout back and forth to friends. They awaken the homeowners who wish to sleep undisturbed. The people leave beer cans, trash and condom wrappers, fish guts and diapers along the road and the access easement. Last week a discarded syringe and needle were left on the street. They use the trees for urination after dark it only gets worse. The resident went on in that vein and evidence the serious impact free access was having on the neighborhood.

Ms. Smith raised the issue of providing a crosswalk for those who had to park at a distance. Page 63

Councilman Nolan pointed out it was a County Road and the County would have to give permission. Councilman Garruzzo added that their Traffic Safety Officer had visited the site and found that visibility was not an issue and there was no impediment to crossing.

Ms. Smith wondered why the violators were not simply arrested. Councilman Garruzzo stated that the Police were working with the residents to address the issue.

In terms of the ordinance it would remain in effect, Ms. Smith expressed her disappointment, but Councilman Garruzzo regretted that he could not make everyone happy.

The meeting was adjourned at 8:09 pm on a motion by Councilman Gianforte seconded by Councilman Gorham.
