The Monmouth County Board of Chosen Freeholders, in conjunction with the Monmouth County Sheriff's Office and the Monmouth County Health Department, are bringing FREE COVID-19 testing to your community.

Open to Monmouth County residents only. No appointments necessary, simply walk up during the times listed below and a health care professional will administer the nasal swab test. Residents do not need to be symptomatic to be tested.
